Please use our Contact update form available on our website or by request.);
- d) Post notice on website of the Special District Association of Colorado ([SDACO](#)) (Note: Your district must be an SDA member. Send notice to SDA by mail or electronic submission); or
- e) For a special district with less than one thousand eligible electors that is wholly located within a county with a population of less than thirty thousand, posting the notice in a t least three public places within the limits of the special district and, in addition, posting a notice in the office of county clerk and recorder of the county in which the special district is located. Such notices shall remain posted until the Tuesday succeeding on the first Monday of the following May.
